Q11. How many people aged 18 and under live in your household?






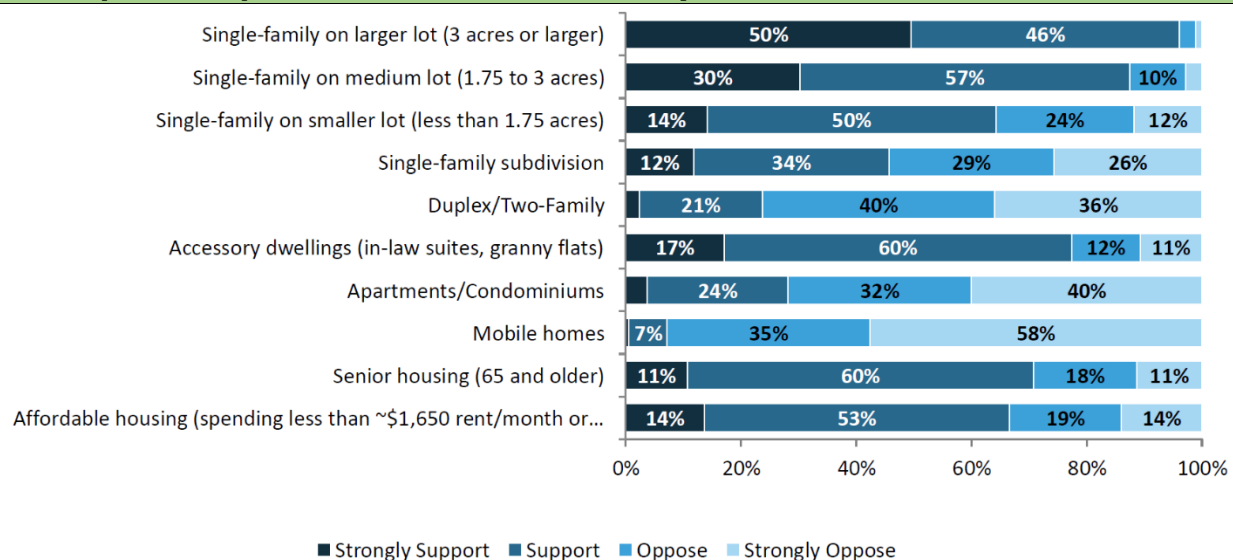

Over the past 5-10 years, residential development has exploded in the lake communities in the township. While this initially was often a somewhat welcome upgrade of older, outdated and in some cases somewhat neglected properties, it has evolved to new houses on old lots that max out every buildable square foot on very small lots, every square foot of buildable area horizontally and vertically going 2 stories plus a walkout level.

Q23. How would you describe the level of nonresidential (commercial/industrial) development in the Township over the past 10 years?








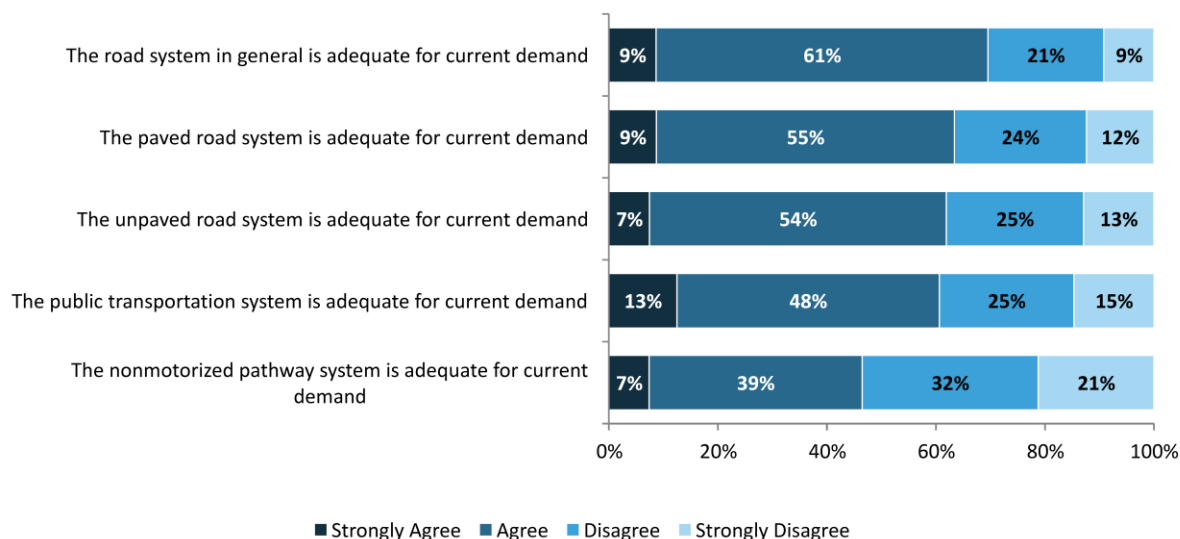

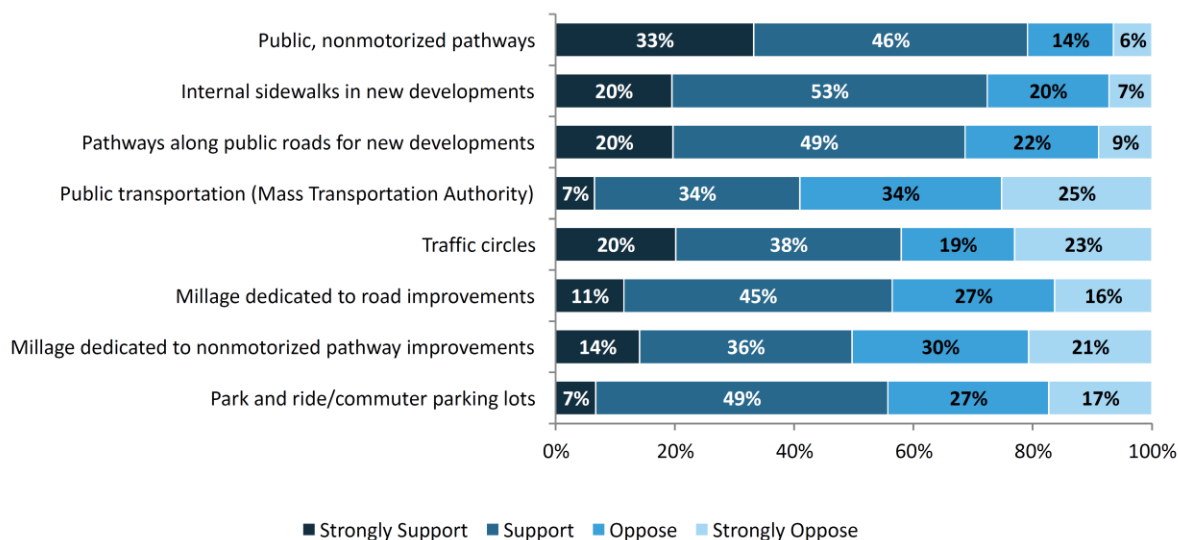

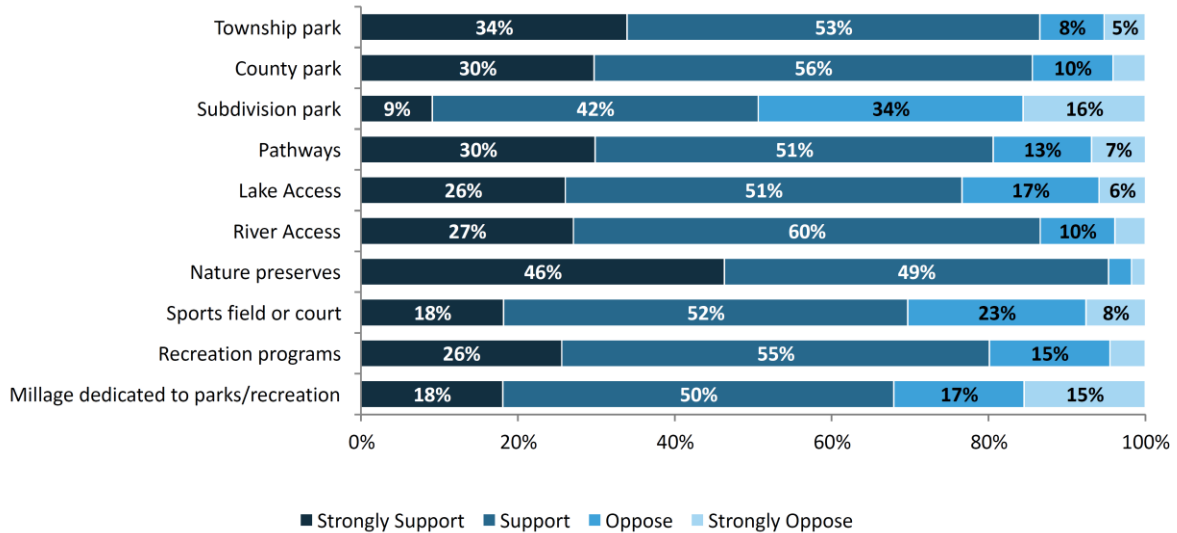

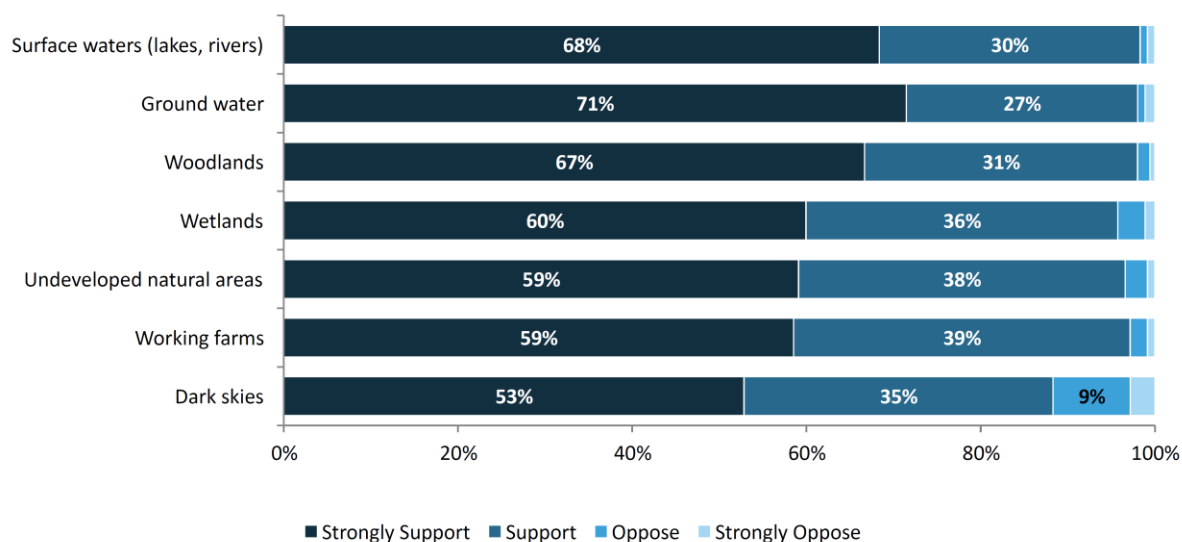
